Important:

An appropriate number of doses of a COVID-19 vaccine referred to in Annex 1 to the Order and the expiry of a 14-day period from the date of administration of the last dose shall be accepted as a completed vaccination course.

The combined intake of one dose of Vaxzevria/AZD1222 vaccine with one dose of Comirnaty/BNT162b2 (Pfizer-BioNTech Covid-19 vaccine) is also considered to be a complete vaccination course.

The document must contain the names of the person written in Latin according to the travel identity document, date of birth, date of last covid-19 vaccine received, serial number of the dose, as well as the total number of doses for vaccines to be given twice, trade name of the covid-19 vaccine inserted, name of the manufacturer/holder of the marketing authorization, country from which it was issued and the name of the issuing competent authority.

The document for persons who have suffered from COVID-19 must contain the names of the person written in Latin according to the travel identity document, details of the medical institution which carried out the test (name, address or other contact details) or of the issuing authority, the date on which the polymerase chain reaction test or rapid antigen test for COVID-19 was carried out, written in Latin method (PCR or RAT) and a positive result, allowing interpretation of the document.
